

Quality Improvement Projects for ACHN Organizations

Each of the seven (7) Alabama Coordinated Health Network (ACHN) organizations is required by the Alabama Medicaid Agency to develop, implement, and monitor Quality Improvement Projects in three categories:

Adverse Birth Outcomes

Childhood Obesity

Substance Use Disorder

According to the Alabama Department of Public Health, the top health concerns in Alabama are (1) mental health and substance use, (2) access to care, (3) poor pregnancy outcomes, and (4) nutrition and physical activity.

As providers in the ACHN, you play a key role in helping us meet our goals and positively impact the health and well-being of recipients in Alabama.

How Can You Help?

Send Referrals to NACC for Recipients who:

- Are pregnant and do not have an OB-GYN.
- Have a substance use disorder diagnosis.
- Are aged 3-6 with a BMI between 85 - 94% at their most recent well-visit.

The Alabama Medicaid Agency has announced that the COVID-19 PHE coverage is tentatively expected to expire on September 30th, 2022. Preparations for the ending coverage is underway. The Agency has asked that Medicaid partners assist in “relaying a consistent and simple message to the Medicaid recipients by sharing key messages from the Agency in your newsletters, social media posts, and other means of communication.”
